PURPOSE	
<p>The position transports water on behalf of the Vuntut Gwitchin Government (VGG) to locations within Old Crow and performs other tasks as directed when water delivery is not needed. Will also provide coverage to operate the bulk fuel delivery truck, as required.</p>	
KEY PERFORMANCE AREAS	
<ul style="list-style-type: none"> • Loads, transports, and unloads water to VGG locations and customers within the community; • Ensures the required load-related documentation is complete and accurate prior to transporting and records the meter count on the delivery truck before filling each tank; • Performs pre- and post-trip vehicle safety inspections as required by law to assure mechanical, safety and emergency equipment, is in good working condition. Performs basic maintenance as needed. Communicates defects and maintenance needs and adheres to a maintenance schedule; • Reports accidents, customer, or delivery problems to the Team Lead and completes incident reports immediately. Communicates any safety concerns immediately; • As assigned during non-delivery hours, carries out labourer functions such as maintenance tasks, cleaning, supporting community events etc.; and • Completes necessary paperwork at the end of the shift. This may include hourly logbook, inspection and repair logs, delivery and fuel receipts, vehicle inspection, hours of service, etc.

<ul style="list-style-type: none"> • Takes precautionary measures and remains up to date with WHMIS, H2S, and Transportation of Dangerous Goods legislation to handle and transport fuel appropriately; • Adherence to traffic laws and regulations; • Attentiveness to weather and road conditions; • Ensures health and safety of self and customers when loading and unloading fuel; • Conducts routine inspections to ensure vehicle and equipment is well maintained to avoid accidents; 	

- Works efficiently to complete delivery schedule and avoid delayed deliveries;
- Accurate completion and submission of required documentation; and
- The VGG Standards of Conduct are modelled and promoted.

Environment:	The driver drives a 5-ton truck and is exposed to snow and extreme cold temperatures.

Hazards/equipment:	Daily exposure to vehicle and aviation fuel, odors/fumes, and operating large vehicles. Personal protective equipment is required.
